## DIRECTOR'S CORNER

Over the past several months, we've had an ongoing conversation about how, why and what TFI is working towards in making the best placement decisions for children. As a foster parent, you have a lot of responsibility in caring for children. Much of what I have shared about TFI's efforts has focused on the system of "Best Match", and how through research with The University of Kansas, we have begun to validate its help in making good placements for children. The efforts to validate, improve and make our matching system the best it can be is all based on doing what is right for children.

Knowing it is now the mid-point of the new school semester, I wanted to share some important information on how critical stable placements are to a child's success in education. From a research report published in July 2011, the National Working Group on Foster Care and Education

found that placement stability was directly linked to a child's educational achievement. In one study, children in foster care with one fewer placement per year were twice as likely to graduate high school. Similar research in this report noted how students who frequently move obtain lower scores on standardized tests.

This type of research and information means a great deal to all of us. We, as the agency and you, as the foster parent, are the ones working to ensure stability in homes. As I am sure many of you experience each day, children in foster often come with existing struggles or challenges in their education. Every decision we make to provide stability for a child in placement is linked back to improving their education as well. As all of us aid children in stability, we are also increasing their chances of life-long success through education. That is so exciting and so

impactful.

In closing, I leave you with a quote about the power of education and the role we play in navigating through the fog:

Have you ever been at sea in a dense fog, when it seemed as if a tangible white darkness shut you in and the great ship, tense and anxious, groped her way toward the shore with plummet and sounding-line, and you waited with beating heart for something to happen? I was like that ship before my education began, only I was without compass or sounding line, and no way of knowing how near the harbor was. "Light! Give me light!" was the wordless cry of my soul, and the light of love shone on me in that very hour.
